

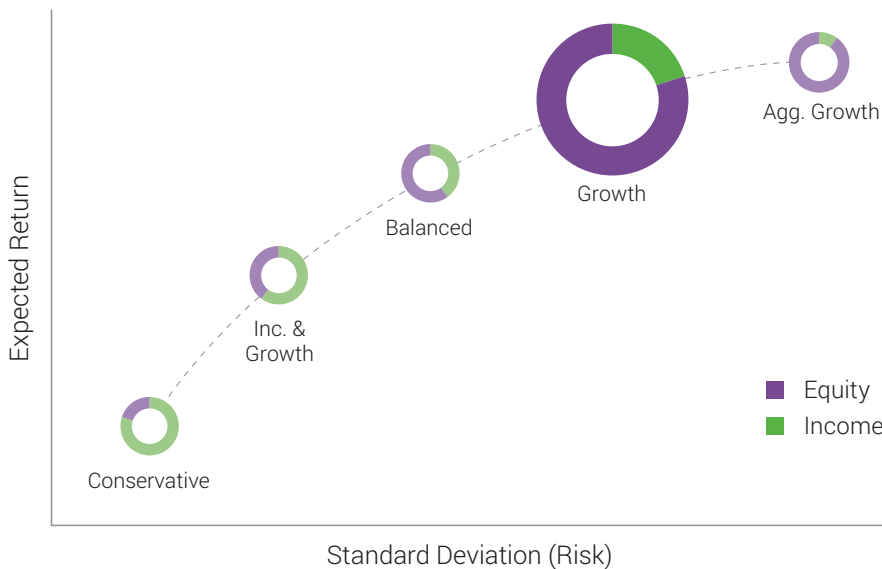
MORNINGSTAR GROWTH ETF ASSET ALLOCATION PORTFOLIO CLASS II

Description

- The Portfolio seeks to achieve this objective by investing in Exchange-Traded Funds (ETFs) that invest primarily in fixed-income securities and money market instruments. A smaller portion of the Portfolio is invested in ETFs that primarily invest in equity securities of large, medium and small sized companies.
