

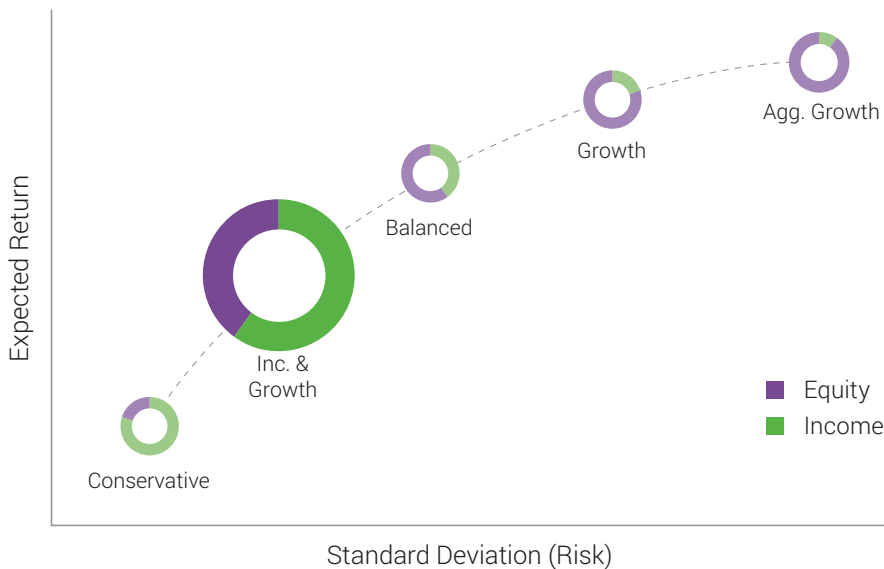
# MORNINGSTAR INCOME AND GROWTH ETF ASSET ALLOCATION PORTFOLIO CLASS II

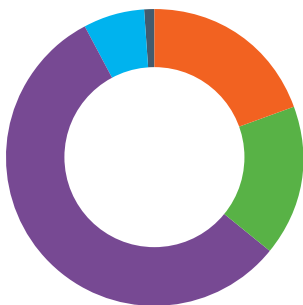
## Morningstar Asset Allocation Portfolios Expand the Efficient Frontier
